To obtain Alumni Feedback on Curriculum during the academic year 2017- 18, IQAC of this college designed a questionnaire. This printed questionnaire was distributed to the alumni.

#### **Observations:**

#### Alumni Feedback analysis:

Feedback questions for alumni are structured with ten in number. The questions are to be answered on five rating scale beginning with Strongly Agree, Agree, Disagree and Strongly Disagree.

#### The curriculam and syllabus content were appropriate for my placement/higher education:

The syllabus should provide enough detail for students to understand what is expected of them and how the course proceeds. Optimally, the course syllabus should generate interest and motivate students to take responsibility to learn the contents of the course.

The above table depicts that around 80% of the respondents strongly agreed and 20% agreed that the curriculam and syllabus content were appropriate for their placement/higher education. Cumulatively all the alumni response is highly positive.

#### Sufficient number of co curricular activities were arranged during my study period:

Majority of the respondents 47% strongly agreed and 52% agreed that co curricular activities were properly arranged during their study period. And all the alumni agreed that there are sufficient number of co curricular activities like Student Seminars, Student Quiz, Students Group Discussion, Project Work etc available in the institute.

#### The institute-industry tie ups were useful for me:

The above table depicts that half of the respondents strongly agreed and half of them agreed that the institute has tie up with industries. Industry tie up facilitates in allowing students to take advantage of apprenticeship or internship while preparing them for real world scenarios. - Opportunities for students to engage intellectually, creatively, emotionally, socially, or physically.
- A designed learning experience that includes the possibility to learn from natural consequences, mistakes, and successes.

The above table depicts that around 36% of the respondents strongly agreed and 63% agreed that the curriculam accommodates courses with experimental learning. Despite this, this institute believes that 63% of the respondents are not strongly agreed and hence looking forwad to enhance the experimental learning component in the curriculam.
